Dear Mr. Neister,

The computer printout at the end of this letter serves as notification of registration of the pesticide-producing establishment for which you applied, pursuant to Section 7 of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA). Each registered established is assigned a unique establishment registration number. This establishment registration will remain in effect, provided pesticide reports on production and sales or distribution amounts are submitted annually as required.

Part 167 of the Code of Federal Regulations (40 CFR) requires your company to submit an Initial report for Pesticide-Producing Establishments, EPA Form 3540-16 within 30 days of receipt of this letter. A copy of EPA Form 3540-16 and instruction for filling out the Form are enclosed so that you may complete that requirement. Please note that the report asks for production amounts for last year, 2005, not this year. Please send me the completed report to me at the address on the top of page 4 the instruction sheet, and retain a copy for your records.

Failure to submit your Initial Report within 30 days may subject your establishment to an administrative civil penalty.

After the Initial Report, future reports must be submitted on a yearly basis. The yearly report forms will be mailed to the company's headquarters mailing address in December of each year. Production reports for establishments registered to produce pesticides and pesticidal devices are due by March 1st as long as the establishment is active, regardless of whether or not production has occurred (regulations pursuant to Section 7 of FIFRA).

Parts of the 40 CFR which apply to pesticide establishments are enclosed for your reference: (1) Part167-Registration of Pesticide and Active Ingredient Producing Establishments, Submission of Pesticide Reports and (2) Part 169-Books and Records of Pesticide Production and Distribution.

Changes in name, address, or ownership of the company or any establishments are to be reported to this office within (90) days of the change. If your company decides to cease production of all pesticides pesticidal-devices, you may request inactivation of this establishment. Requests for inactivation of establishments are also be sent to this office.

The container of each pesticide product which is released for shipment must bear the EPA Establishment Number assigned to the establishment in which it was produced. This number, which is to be preceded by "EPA Est.", may appear in any suitable location on the label or immediate container. It must also appear on the outside container or wrapper of the package if the EPA establishment Number on the immediate container can not be clearly read.
